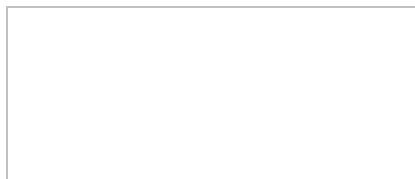
The final deadline for program changes is March 12, 2024. This includes changes to paper titles, session titles, and authors, as well as Session Chairs and Discussants.
