Congratulations! Please note that all presenters must confirm their continued interest and ability to present at the conference by completing the online form (link below). Items in the online acceptance form include the following areas that you will need to confirm and agree to:

- Your attendance at the 2024 NAfME Biennial Conference. All presenters, including your copresenters, must register for the conference by July 1.
- Your understanding that NAfME (the program committee) will select the date/time of your presentation within scheduled days/hours of the conference and inform you of your scheduled time in mid-August. We are not able to accommodate individual requests.
- Your understanding that to accommodate as many presenters as possible and minimize room changes, SMTE and SRME sessions will be set Theater style.
- Your confirmation of the audiovisual set up: Please note for AV purposes, a screen and projector, laptop, and podium mic will be provided in your session room. You may use your own laptop if needed, and Wi-Fi access will be provided. However, because we can't guarantee livestreaming quality, and to expedite set up and flow between sessions, we strongly encourage presenters to download all session materials in advance, including videos from Vimeo or YouTube (etc.), and have them prepared on a thumb drive.
- Your current status as a member of NAfME in good standing and agreement to maintain this status through the conference.

ADDENDUM - SESSION FORMAT SPECIFICATIONS

Research Presentation – Presentations will be allotted 25 minutes total, to include 20 minutes for the presentation and 5 minutes for questions and answers.
