Registration Materials (Convention Program and Name Badge):

All registration materials will be distributed onsite in Chicago. If you choose to receive a printed program prior to the convention, you will need to make that request by July 5, 2019 when registering for the meeting. A fee of \$5 for the Program book and a fee of \$10 will be charged to cover first class priority postage. Convention Program books will also be available in Chicago with a charge of \$5 per book.

A small silicon microchip (RFID tag) is embedded in the name badge. APA is using RFID to monitor traffic in and out of the Solutions Center and to track attendance at CE Sessions. Individual rooms where CE sessions are held are wired to capture in/out times of attendees claiming credits. In this case, individuals are tracked while attending CE sessions. The information captured to track CE session attendance is not used for any other purpose. These RFID tags are passive tags and only can function when within 8 feet of the electronic sensor (the reader).
