Mark your calendars for Monday, September 18 at 3:00 pm EDT for our webinar How to Make & Present a Poster. This one-hour webinar, moderated by Dr. Ekaterina Likhtik and featuring Dr. Marina Picciotto and Dr. Stephen Maren, will discuss key points of poster preparation and presentation, including where to start, how to visualize your ideas using text and figures, how to present to different audiences, how to handle questions and discussions at your poster, and how to follow up with your audience. Presentation of your poster may take place in-person only, virtually only, or both in-person and virtually. All abstract presenters are encouraged to present their poster virtually. Virtual poster presentations will consist of an uploaded poster PDF with the option to upload a video. An asynchronous text chat will be available for each poster for registered annual meeting attendees to leave questions or comments. Virtual-only abstracts will not be sessioned into nanosymposia. Virtual posters will be available for registered Neuroscience 2023 participants approximately one week before the annual meeting through 30 days following the end of the meeting. All virtual poster content must be uploaded by October 27, 2023. For details on uploading virtual poster content, review the virtual poster presenter resources.

In-person presenters will be notified of their specific one-hour presentation times within their session day and time later this fall. You will also receive further tips for preparing your virtual and physical poster presentations at that time

Poster boards are six feet (1.8 m) wide and four feet (1.2 m) high and are in landscape orientation. You are expected to mount your poster 15 minutes before your assigned session begins and leave the poster in place for all four hours of the session. You are required to stand at your poster only during your presentation hour. During the rest of the session, you are welcome to attend other presentations. When the four-hour session is over, you must remove your poster from the board for the next presenter. Posters remaining at the end of the session will be discarded.

To increase searchability and networking, virtual-only posters are sessioned with inperson posters. These sessions were created by the Program Committee around similar topics. However, to be respectful of time zones, if you are a virtual-only presenter, you are not required to be present in the virtual platform during the designated session time above. Virtual posters will be available for on-demand viewing and asynchronous text chat from November 2 - December 15.

Use the buttons at the end of this notification to **continue** and complete presenter tasks (update participation preference, update author block, review session assignment, register for Neuroscience 2023) or withdraw your submission.

If you select "Withdraw", you are indicating that you no longer want to have your abstract included in the annual meeting program. Remember, for the 2023 annual meeting, presenters have the option to present in-person, virtually, or both. Your abstract can be included in the program even if you do not plan to travel to Washington, D.C. For details on the different abstract presentation formats for Neuroscience 2023, visit SfN.org.

## **Poster Presenter Tasks**

- Register for the annual meeting You must be registered to upload and present your abstract. The \$155 abstract handling fee does not include registration. To register, visit www.sfn.org/registration.
- Review your poster session The SfN Program Committee has reviewed all abstracts and placed them into appropriate sessions. Requests may be made to change your assigned poster session, if you feel you were assigned a session that does not fit the content of your abstract. Requests for session changes outside of this circumstance will not be honored. Requests are due no later than August 24, 2023 and may be sent to program@sfn.org.
- **Review your author block** If you need to update your author block, you will be able to do so at this time. You will be allowed to edit your abstract's author block until August 24, 2023. You will only be allowed to update your abstract's author block. No updates to other sections of your abstract will be allowed or accepted. Verify your author block and make any necessary edits prior to the deadline. Before finalizing your author block, remember to check with your co-authors to see if any changes are needed. Co-authors cannot access the abstract to make changes to the author block. Requests for author block edits received after Thursday, August 24, 2023 will be denied.
- **Update your meeting participation** On the following page, you will be asked if you plan to present your abstract in the meeting in-person only, virtually only, or virtually and in-person. Please be sure to provide an updated answer to this question, even if it is the same response you provided during abstract submission. You do not have to update your response via email to SfN. Your responses will help SfN staff to better plan for the annual meeting. As a reminder, any decision to switch from virtual only to in-person must be made by August 25, after which your poster cannot be guaranteed to be placed near the other posters in your poster session. The deadline for switching from in-person only to virtual only is October 30, as we know that

people may be unable to anticipate reasons for this switch until right before the meeting.

## Scientific Rigor

Scientific rigor is the structured and controlled application of the scientific method using the highest standards in the field, including considerations in experimental design, data analysis, and reproducibility. Annual meeting presenters will be expected to transparently report a study's experimental design and analytical methods in their presentation.

By submitting your abstract, you agreed to the following statement:

I will transparently report my study's experimental design and analytical methods in my presentation at the annual meeting. I understand that efforts to ensure scientific rigor including blinding, statistics, sample sizes, and replication should be explicitly stated; that error bars should be defined; and that biological variables such as species, sex, age, strain, or cell line should be noted in the presentation if applicable.
