Thank you for submitting a proposal for the Association for Counselor Education and Supervision 2021 Conference. You are receiving this email as the first author of a submitted proposal(s). We received an overwhelming number of excellent proposals this year. Congratulations, your proposal "**Walk the line: Helping students ethically navigate pandemics and professionalism without becoming their counselor**" has been accepted! For your information and records, the overall conference proposal acceptance rate this year was 60.03%.

**Please read this message carefully because it contains important details about your presentation.**

Your session "**Walk the line: Helping students ethically navigate pandemics and professionalism without becoming their counselor**" was accepted as a 30-minute poster session. It is scheduled for Friday, 8th from 2:00 pm - 2:30 pm in Grand Hall West- Board 14.

As you agreed to when you submitted your proposal, no changes to your presentation day/time can be made. You may edit your authors and authorship order until June 11 at 7pm Eastern Daylight Time only via the [ACES 2021 Accepted Session Authorship Change Form](#).

After June 11th, the only changes that may be made are cancellations. Please note, individuals can be listed on no more than two peer-reviewed presentations (including ACES INFORM). If a person is listed on more than two presentations, the presentation is subject to cancellation. You are responsible for communicating with your co-authors about presentation decisions, dates, times and locations. Finally, the lead presenter must be registered for the conference by July 30, 2021 otherwise your proposal will be cancelled.

Due to COVID-19 restrictions, in person registration for the [ACES 2021 conference in Atlanta, GA October 5-10, 2021](#) will be limited to 950 participants. To accommodate presenters, registration will initially be opened only to accepted presenters and the registration link is included below. Registration will be on a first come, first serve basis for presenters. For presentations with multiple presenters, it is highly encouraged for at least one person from the presentation to register ASAP. No presentations will be cancelled if some members of the presentation team cannot register. Based on communication from the Hyatt Regency, it is expected that social distancing guidelines may allow for more registrations to be added in the future, but the timeline is not guaranteed. The Hyatt is following the current CDC guidelines of 6-foot social distancing to ensure attendee safety. ACES appreciates your patience and communication will be forthcoming if guidelines are changed.

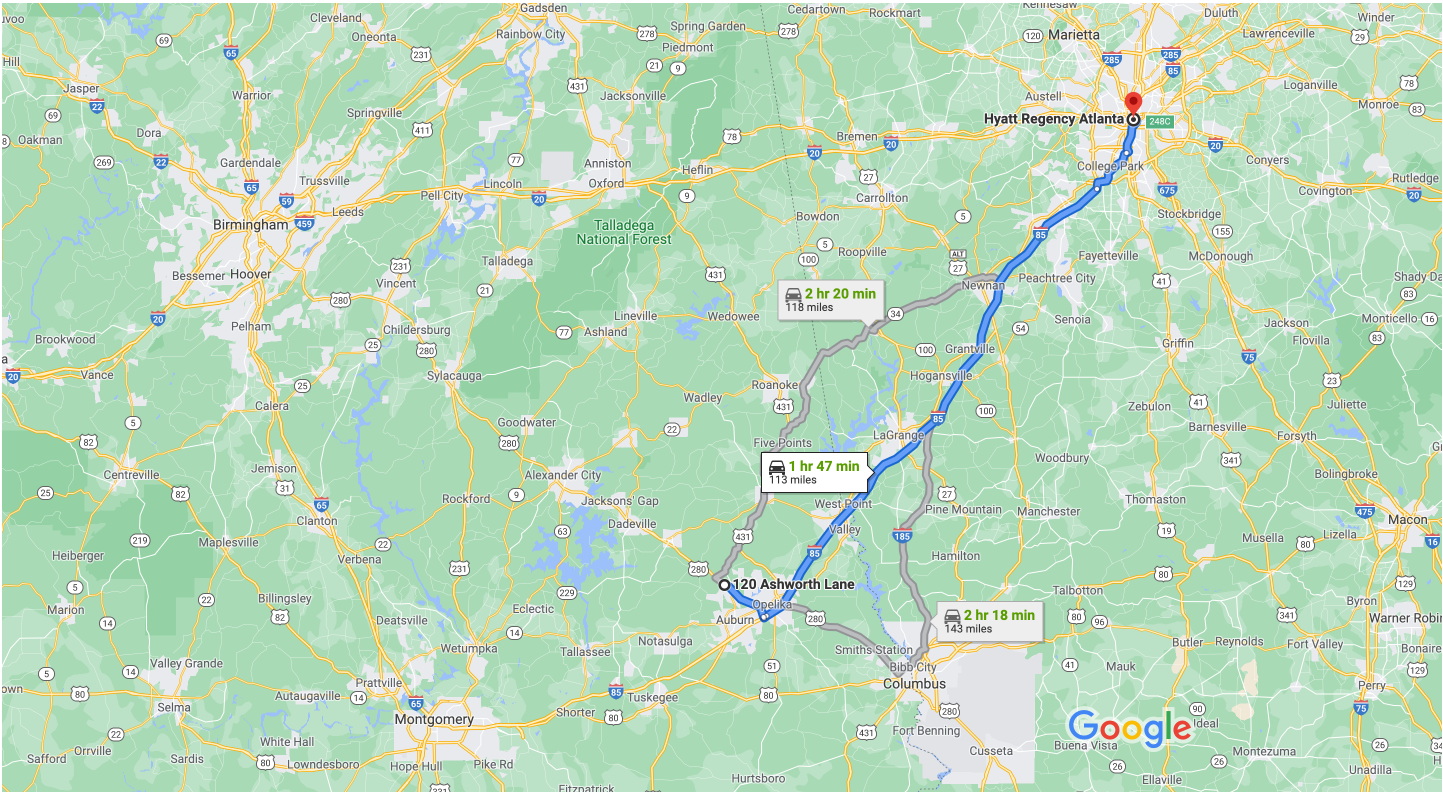
