#### Registration

Presenters for all in-person sessions must be registered for the ASHE General Conference and/or respective Preconference(s). The Early Registration deadline is August 5, and the registration deadline for chairs, discussants, and presenters is September 15. This deadline helps the ASHE Staff and Program Committee ensure your attendance at the conference. #### Information for ASHE 2023 In-Person Sessions

#### **Paper Presentations**

If you are presenting a paper (self-designed, scholarly, or research), you must upload a PDF copy of your full paper (no longer than 30 double-spaced pages) for your Discussant and Chair no later than October 31, 2023 at 4:00 pm Central/Minneapolis Time.

### Performance, Visual, Digital Scholarship (PVDS) Individual Presentation

If you are delivering work in the PVDS format, you must upload a PDF copy of your full paper (no longer than 30 double-spaced pages) or notes for your Discussant if the final form of your presentation will not be a traditional manuscript. One of these options must be completed no later than October 31, 2023 at 4:00 pm Central/Minneapolis Time.

### <u>Interactive Symposium and Performance, Visual, and Digital Scholarship Sessions</u>

If you are delivering your work in an Interactive Symposium or a PVDS Session, please note that you are responsible for coordinating the presenters and the flow of your session. Final papers are not required or able to be uploaded.

#### **Posters**

If you are presenting a poster, you must create a poster size 48" high x 36" wide for the in-person Poster Session. A display board will be available to showcase your work.

More information for creating accessible posters will be provided in the 2023 Presenter Guide, which will be available at the end of August. Final papers and PowerPoint Presentations are not required or able to be uploaded.

### **Works In Progress**

If you are delivering your work in a Works in Progress Session, you are encouraged to create material providing an overview of your work, such as a very brief PowerPoint presentation and/or one-page handout focusing on an overview of the project, purpose, and questions to engage the audience. Final papers are not required or able to be uploaded.

## **Uploading PowerPoint Presentations**

All presenters agree to upload their PowerPoint presentations by November 7, 2023 at 4:00 pm Central/Minneapolis Time. We ask presenters to use PowerPoint for its accessibility features. Uploading your PowerPoint allows attendees to preview the presentation materials ahead of time for better engagement with the session as well as allows the captionist/interpreter to preview the presentation to ensure accurate translation of materials. More information for creating accessible presentations will be provided in the 2023 Presenter Guide which will be available at the end of August.

#### Adding/Removing Authors and Editing Title/Abstract

Once proposals are accepted, some authors may need to make changes, such as adding additional authors, making minor spelling or grammatical changes to their title and/or abstract, or withdrawing from the conference. No changes will be accepted after July 14, 2023 at Noon Central/Minneapolis Time.
