There are two options for scheduling with accommodations. You can self-schedule your exam online or schedule with a testing accommodation representative over the phone.

Register Online:

Praxis at Home- To self-schedule your Praxis at Home exam, you must log in to your ETS account, select the Praxis at Home option, and pay for your test. For more information on the equipment requirements, registration procedures, and testing experience for Praxis at Home, please visit www.ets.org/praxis. Once registered, you will receive an email from ProctorU with instructions for scheduling your test date and time. If you need to cancel your Praxis at Home test appointment, contact ETS.

Physical Testing Center- To self-schedule your exam, you must log in to your ETS account and schedule your exam. You also have the option to reschedule or cancel your appointment.

Register by Phone:

Physical Testing Center- To schedule your exam with a Prometric representative, you must call the Prometric Testing Accommodation Call Center at **1-800-967-1139 (Option #2).** Be prepared to verify your approved testing accommodations and provide payment. If you need to cancel or change your appointment, you must call Prometric at the number above.

You must have this authorization letter on test day, along with proper identification bearing your photograph and signature. Your ID requirements depend upon whether you are taking the test within or outside your country of citizenship. Information about acceptable primary

and supplemental ID documents is available in the Praxis Registration Bulletin or on the Praxis website at www.ets.org/praxis.

If you need to retest, note that tests may not be retaken within 28 days of your initial test date. To reregister with your approved accommodations for the test(s) above, you can use either the online or phone scheduling options described above. Note that the registration system will only allow you to register for a test date that is at least 28 days after the previous test date.

NOTE: If you are taking a computer-delivered test, the testing sites are only aware of the duration time. The test duration is NOT the time allotted to complete the test. The duration time includes time to assure that the test taker has enough time to be checked in, complete the tutorial, complete the exam and resolve any unforeseen issues. To find the standard testing time and get a breakdown of the types of questions you will encounter on the exam, please view the Study Companion or Test at a Glance, at www.ets.org/praxis/prepare/materials.. You will need to multiply the standard time by your approved extended time to figure out how much time you should be allotted for your exam (for time and half multiply by 1.5, if double multiply by 2, etc.) Please be advised you must start the exam for the extended test time to launch.

If you have a physical disability and require assistance in activities such as getting to the testing room, using the restroom, or eating lunch, you are responsible for having someone approved by ETS Disability Services with you at the test center to provide these services. Test center staff can only provide services directly related to test taking. The person accompanying you will be permitted in the testing room only as the need arises.
