Praxis Test Information:

It has come to our attention that ETS has recently adjusted certain verbiage on their website. It currently states that entering your social security number is optional. Per the Alabama State Department of Education, your social security number on your assessments is required as part of your certification. Please be sure that when you register/ed to take the assessment that you have your scores sent to both ALSDE and Auburn University (codes are below). We have had several students lately not send to Auburn and I do not want you having to pay to send them to us separately. Also, PLEASE be sure you enter your social security number correctly when taking your assessments as well. This will cause you to have to fix it and pay to have scores resent as well so please review these items carefully. Thanks!

Note: Auburn University (Code 1005) and Alabama State Department of Education (Code 7020) must be recipients of your score report from Praxis II (ETS). Only official score reports sent directly from Educational Testing Services (ETS) to Auburn University and the Alabama State Department of Education will be accepted as documentation of a passing Praxis II score.
