### **Course Description:**

Field project formulated, planned, conducted, evaluated, and reported in appropriate written and oral formats under the direction of the student's major professor.

**Course Objectives:** Upon completion of this course, students will be able to:

Formulate, plan, conduct, and report in appropriate written and oral formats an original field project under the direction of the student's major professor.

**Course Content and Schedule:** Course content will follow the sequencing of objectives and course requirements. The student will submit a timeline for completing the project and the accompanying presentation that will be approved by his committee.

# **Course Requirements/Evaluation:**

Student is required to complete the following components/activities:

- A. Prepare a proposal for the field project and obtain the approval of the student's graduate advisory committee.
- B. Compile an extensive review of the pertinent literature.
- C. Formulate appropriate methodology and procedures for completing the project.
- D. Obtain Institutional Review Board approval for research dealing with human subjects if appropriate.
- E. Conduct the field project with the concurrence and guidance of the student's graduate advisory committee.
- F. Analyze and interpret the findings or results of the project.
- G. Write a summary of the project following approved guidelines.
- H. Orally defend the results of the field project.

No grades are assigned to the Field Project.

### **Class Policy Statements:**

Participation: Students are expected to participate in all class discussions and participate in all

exercises. It is the student's responsibility to contact the instructor if assignment deadlines are not met. Students are responsible for initiating arrangements for missed work.

Attendance/Absences: Attendance is required at each class meeting. If an exam is missed, a make-up exam will be given only for University-approved excuses as outlined in the <u>Tiger Cub</u>. Arrangement to take the make-up exam must be made in advance. - CTSE 7520 (3) if not previously completed and currently teaching,
- CTSE 8980 (minimum 1 hour) if CTSE 7520 previously completed and the candidate has not done a field-based professional work sample.
