# **Course Description:**

Field project formulated, planned, conducted, evaluated, and reported in appropriate written and oral formats under the direction of the student's major professor.

# **Course Objectives:**

Upon completion of this course, students will be able to:

Formulate, plan, conduct, and report in appropriate written and oral formats an original field project under the direction of the student's major professor.

## **Course Content and Schedule:**

Course content will follow the sequencing of objectives and course requirements.

### **Course Requirements/Evaluation:**

Students are required to complete the following components/activities:

1. Prepare a proposal for the field project and obtain the approval of the

- student's graduate advisory committee.
- 2. Compile an extensive review of the pertinent literature.
- 3. Formulate appropriate methodology and procedures for completing the project.
- 4. Obtain Institutional Review Board approval for research dealing with human subjects if appropriate.
- 5. Conduct the field project with the concurrence and guidance of the student's graduate advisory committee.
- 6. Analyze and interpret the findings or results of the project.
- 7. Write a summary of the project following approved guidelines.
- 8. Orally defend the results of the field project.

Evaluation: Satisfactory or Unsatisfactory/No letter grades are assigned to the Field Project.

#### **Guidelines:**

Guidelines for the Field Project are developed by the candidate for the Education Specialist or Doctoral degree and the major professor with input and approval from the candidate's committee members if they have been selected. Each Field Project addresses a topic selected by the individual candidate, and the outcomes range from the development of curriculum and/or assessment systems to field tests and evaluations of commercial programs of instruction or even descriptive, quasi-experimental, and action research studies. Projects may take other forms as well. If the candidate is a teacher working with students in his or her own classroom to complete a Field Project based on action research or development and implementation of a curriculum program or assessment system that is sanctioned as part of his or her professional teaching responsibilities, the Institutional Review Board (IRB) and Office of Human Subjects Research do not require a protocol and IRB approval for the Project. If the candidate conducts a study with students for whom they are not responsible as teacher or subjects any students to treatment, control, or any other conditions that are not part of the routine practice within the school, an IRB protocol and approval is required.
