**Course Description**

Concept and skill development in physiologic testing, test selection, and interpretation in normal and special populations.

**Student Learning Outcomes**

Explain and discuss the underlying physiology and principles of health and fitness assessment in accordance with American College of Sports Medicine (ACSM) guidelines.

This prepares the student to take either the ACSM Personal Training or Health/Fitness Specialist certification.

The course will also provide information and hands on experience that may also assist in preparation for certifications from the National Strength and Conditioning Association or the American Council on Exercise.

**Assignments/Projects**

Five (5) exams. Exams can include multiple choice and/or true/false.

## **Class Policy Statements:**

### Attendance

Although attendance is not required, students are expected to attend all classes, and will be held responsible for any content covered in the event of an absence.

### Excused absences

Students are granted excused absences from class for the following reasons: illness of the student or serious illness of a member of the student's immediate family, the death of a member of the student's immediate family, trips for student organizations sponsored by an academic unit, trips for university classes, trips for participation in intercollegiate athletic events, subpoena for a court appearance, and religious holidays. The instructor will weigh the merits of the request and render a decision. When feasible, the student must notify the instructor prior to the occurrence of any excused absences, but in no case shall such notification occur more than one week after the absence. Appropriate documentation for all excused absences is required. ### Make-Up Policy

Arrangement to make up a missed major examination (e.g., hour exams, mid-term exams) due to properly authorized excused absences must be initiated by the student within one week of the end of the period of the excused absences(s). Except in unusual circumstances, such as the continued absence of the student or the advent of university holidays, a make-up exam will take place within two weeks of the date that the student initiates arrangements for it. Except in extraordinary circumstance, no make-up exams will be arranged during the last three days before the final exam period begins.
