a. Methyl Bromide Substitution

Continue two trials and add two trials (USDA Areawide)

It is discussed between meeting participants (D. Shelburne, G. Hernandez, S. Enebak and others) whether or not the Coop is "spinning its wheels" with this trials due to the pending EPA regulations. Regulations will be enforced by 2010. We at least will not be wasting money because these trials are done using AreaWide money; however, the time is that of our Nursery Cooperative technicians and researchers.
