General Information

PERSONAL PROTECTIVE EQUIPMENT

In addition to Personal Protective Equipment for applicators and other handlers listed on the EPA-registered label, the following personal protective equipment is required when loading containers into trucks:

- chemical-resistant footwear plus socks
- chemical-resistant apron

ENVIRONMENTAL PRECAUTIONS: TAKE CARE TO AVOID THE PUDDLING OF DIAZINON DRAINED FROM CONTAINERS FOR EXTENDED PERIODS OF TIME ON PLASTIC SOIL COVERINGS SINCE THIS MAY POSE A DANGER TO WILDLIFE. DO NOT APPLY DRENCH TREATMENTS IN AREAS WHERE RUNOFF COULD OCCUR INTO LAKES, PONDS, OR STREAMS.

Nursery Stock, INCLUDING NONBEARING FRUITS AND NUTS:

Mix 1 pint of D.z.n diazinon AG500 in 100 gallons of water and thoroughly saturate the growing medium of the containerized nursery stock. The amount of solution used per plant is generally 1/5 the volume of the container.

When applying diazinon for the purposes of complying with the Federal Fire Ant Quarantine Program, applications should take place at least 3-4 hours before shipment to allow for adequate drainage and drying of the containers before loading. Certification of nursery stock may take place immediately following the 3-4 hour standing time. Nursery stock treated with diazinon may be certified free of IFA's only for a 10-day period after treatment.

Note: Since cultivars may vary in their response to treatments with diazinon, you are advised to test applications on a few plants prior to treating the entire nursery. Be sure to apply under the same conditions anticipated for the final treatment.

Chemigation: DO NOT apply this product through any type of irrigation system.
