Re: Dean – College of Architecture, Design and Construction (CADC).

Dear Members of the Search Committee,

This letter is written in response to my nomination for the position of Dean of the College of Architecture, Design and Construction at Auburn University. I am honored to have been identified as a candidate. I am drawn to the challenges and opportunities presented as a result of the underlying focus of the College on exceptional teaching, practice, research, experiential learning, and creative inquiry. It is empowering to learn that the diverse degree programs in the College aim to support designers, makers, thinkers, builders, and problem solvers to improve the lives of the people of Alabama, the nation, and the world.

At present, I serve as Director of the School of the Built Environment (SBE) at Bowling Green State University (BGSU). The School comprises of two departments – *Architecture and Environmental Design* and *Construction Management*. Prior to this engagement, I served as Director of the *Architecture Department* and Assistant Dean of the *School of Architecture* (SOA) at Prairie View A&M University (PVAMU), Texas – one of only seven HBCU NAAB-accredited architecture degree programs in the nation. The SOA at PVAMU comprised of several departments, including: *Architecture*; *Construction Science*; *Digital Media Arts*; and *Community Development*. Per the search description, the Dean of the College of Architecture, Design and Construction will be responsible for six primary assignments. I have extensive experience in these areas, as described below.

1. Set a Compelling Vision for the Next Chapter of the College

As Director of SBE at BGSU, I spearheaded an ambitious school expansion proposal, developed programmatic needs, and secured funding for a new 23,000 sq. ft. facility for the Construction Management Department. This integrated facility physically unified all programs in the School and features a state-of-the-art innovation lab, digital classrooms, materials lab, and other program supporting components.

At BGSU, I worked with faculty and staff to increase enrollment in the architecture and construction management undergraduate and graduate degree programs. During the past 6 years, the architecture undergraduate program grew more than 300% in terms of enrollment, while the construction management undergraduate program grew more than 200%. During the same time-period, the graduate programs in the School (M.Arch. + MTM-CM) grew more than 300% in terms of enrollment.

As SBE Director at BGSU, I led the NAAB and ACCE accreditation efforts in the School. As part of these efforts, I wrote and submitted the *Architecture Program Report* for NAAB Initial Accreditation in 2019 and NAAB Continuing Accreditation in 2023, and coordinated all documentation/evidence, including logistics related to the site visits. In terms of ACCE accreditation, I wrote and submitted the *First-, Second-, and Third-year ACCE Accreditation Progress Reports* and prepared the *Self Evaluation Study* including compilation of all Student Learning Outcome (SLO) documentation for the fall 2023 Continuing Accreditation visit. I also coordinated the creation of a new ACCE-aligned *Quality Improvement Plan* (QIP) for the Construction Management Department in collaboration with faculty, staff, students, and industry partners. In addition, I developed new assessment plans for all programs in the School and established seven new (annual) assessment procedures for NAAB, ACCE, and Higher Learning Commission (HLC) accreditation efforts. All relevant programs in the School are now accredited at the highest levels.

2. Effectively Manage the CADC Budget and Enhance the School's Financial Strength

As SBE Director at BGSU, I am responsible for planning and managing the budget for the Department of Architecture and Environmental Design and the Department of Construction Management. During the past six years, I worked extensively with *BGSU Advancement and Development* to enhance the School's financial strength. Since 2018, I have personally met and networked with over 100-plus donors and industry partners – these efforts have directly resulted into major gifts for the School in *excess of \$4.5 Million* (see cv for details). As part of these efforts, I secured a \$1 million gift from Owens Corning Foundation to create scholarships for recruiting under-represented students in the School. Most recently, I secured donor funding (\$150,000) to successfully establish a new “School of the Built Environment Enhancement Fund”.

3. Support and Enhance Teaching, Practice, and Research

Testament to my qualifications, I have maintained a balance between academic and professional interests – I am a registered architect and simultaneously, I have been an active researcher, educator, and administrator. Within this context, I hold several professional/industry-related certifications, including; *LEED AP; Evidence-Based Design Accreditation and Certification; Certificate in Health Systems and Design; Straw Bale Design Build Certification*; and *NCARB*. I am also a Registered Architect in India and Texas. In conjunction with my research interests, I have been fortunate to collaborate extensively with my fellow peers across disciplines, and present peer-reviewed research papers at several national and international conferences and symposia, including publications in peer-reviewed journals.

As SBE Director at BGSU, I coordinated efforts with school faculty and advisory boards to revamp the curricula to capitalize on underlying synergies between both departments in the School. Among several curricula changes, the total credit hours for the B.Sc. in Architecture degree were reduced from 126 to 122, while the B.Sc. in Construction Management total degree credit hours were reduced from 127 to 122. In addition, the total credit hours for the M. Arch. degree were reduced from 52 to 49, while the Master of Technology Management in Construction Management (MTM-CM) total degree credit hours were reduced from 33 to 30. These changes are now enabling students to graduate in a more efficient and timely manner.

At BGSU, I coordinated the creation of “Accelerated Tracks” of study for undergraduate students in both programs, leading seamlessly to the graduate programs (M. Arch. & MTM-CM). As part of this effort, I collaborated with other department chairs and directors and secured approval to add 20-plus additional electives (from other colleges) to the architecture and construction management curricula in the School. In addition, I worked with external consultants to conduct market studies for the creation of new certificate programs in the School - *Facility Management, Health Systems and Design, and Sustainable Design*. As part of this initiative, I worked with *BGSU Advancement and Development* to secure a major donor gift of \$500,000 for a new *Facility Management Scholarship*.

At BGSU, I have supported faculty teaching, practice, and research initiatives by securing new equipment for faculty and students including, but not limited to: 1 digital compression testing machine; 1 bench oven; 4 three-dimensional printers; 7 robotic surveying stations; 100-plus computer workstations; multiple new printers/plotters; 2 flatbed CNC routers; 2 laser cutters; and one 10-ton crane (in-progress). In addition, I supported school faculty by preparing comprehensive teaching schedules (spring, fall, and summer semesters) and streamlining course offerings to meet programmatic needs of new ‘4-year Departmental Course Roll-outs’. In addition, I supported and mentored faculty via faculty professional development funding. I also coordinated and supported school faculty with the development of four new comprehensive policies, including: 1) SBE Reappointment, Tenure, and Promotion Policy; 2) SBE Merit Policy; 3) SBE Graduate Faculty Status Policy; and 4) SBE Faculty Peer Evaluation Policy.

4. Recruit and Retain Exceptional Faculty and Staff

As SBE Director at BGSU, I currently supervise and mentor two department chairs and graduate program coordinators. In addition, I am responsible for mentoring and professional development of 15 full-time faculty, 10-plus adjuncts, and 2 staff members. This includes annual performance reviews, enhanced performance reviews, annual merit reviews, tenure and promotion reviews, and annual faculty success plans. In conjunction with school faculty, I reviewed program requests to hire new faculty and prepared/submitted all hiring documentation onward to the Provost's office. These efforts have resulted in the successful hiring and retention of nine highly qualified faculty over the past six years at BGSU. At PVAMU, I was responsible for assisting with the supervision and mentoring of three program directors in the School (*Construction Science; Community Development; and Digital Media Arts*), including supervision and mentoring of 20 full-time faculty, 10-plus adjuncts, and 5 staff members.

5. Sustain and Expand a Culture of Inclusion and Belonging

In terms of leadership, my first instinct is to respect the students, faculty, staff, and other stakeholders with whom I collaborate, and I work hard to earn their trust. I try to be as efficient as possible, and lead by example. In my leadership roles to date, I have always strived to make informed decisions based on consultation and the collective shared vision of all stakeholders. I am committed to a vision that is grounded on self-motivation, collaboration, shared governance, and empathy. The NAAB visiting team in its *Visiting Team Report* for Bowling Green State University in 2019, highlighted my leadership contributions in its summary statement (see pg. 3 of 32 of 2019 - BGSU NAAB VTR)

During the past six years at BGSU, I have worked on several *Inclusion and Belonging* efforts, including:

- Writing several proposals (as part of *Graduate Enrollment Enhancement Initiative*) and securing funding in excess of \$200,000 for recruiting female graduate student assistants in the School.
- Spearheading curriculum changes for two courses (ARCH 3310 & ARCH 6800) that resulted in their inclusion in the "2020-2022 ACSA Equity Course List" – Courses Addressing Justice, Equity, Diversity, and Inclusion in the Built Environment.
- Participating (by invitation) in Multicultural Initiatives for Graduate Student Success (MIGSS) - "Men Mentoring Men Panel" as a panelist, at BGSU.
- Attending workshops and serving (by invitation) in the Northern Ohio AGEP Alliance (NOA-AGEP) to support the success of under-represented minority students in the STEM professoriate career pipeline.
- Attending (by invitation) and serving on the Provost's committee for increasing Latino-student presence on campus.
- Serving on the Dean's Advisory Committee for Diversity Inclusion (DACODI).
- Working with National Association of Minority Architecture Students (NOMAS) to host Dr. Ed Jackson Jr. (Architect for Martin Luther King Memorial in DC) as Keynote Speaker on campus (March 16, 2023).

As an educator at Prairie View A&M University, I devoted ten years of my life to teaching and mentoring under-represented and minority students, faculty, and staff at a Historically Black College/University (HBCU). During this time, I was able to recruit, teach, and mentor under-represented faculty, staff, and students in various capacities (see cv for details). In conjunction with these efforts, in 2016, I was invited to participate (as part of a cohort of PVAMU delegates) and attend the "2016 White House Initiative - National Historically Black Colleges and Universities Conference" – HBCUs: Promoting Excellence, Innovation, and Sustainability" in Washington, DC.

6. Increase the Visibility of the College


As SBE Director at BGSU, I networked extensively and expanded board membership for the *Architecture Advisory Board* and *Construction Management Industry Advisory Board* in the School. As part of this effort, I led the creation of formal “Industry Advisory Board Charters” in the School. Currently, I serve as faculty advisor and coordinate career fairs, industry golf outings, and industry spotlight events in collaboration with *American Institute of Architecture Students (AIAS)* and *Students Construction Management Association (SCMA)* in the School. In addition, I am responsible for industry outreach efforts, and I provide oversight for the SBE co-op program and support students engaged in summer co-ops in the School (approximately 200 internships every summer for the past 6 years). In terms of national-level accreditation-related representation efforts, I have served on visiting teams for both NAAB and ACCE.

In 2017, I was designated a *Japan Studies Institute Fellow* by the American Association of State Colleges and Universities (AASCU). In January 2022, I was appointed by the American Institute of Architects Ohio Board to serve as its AIA Ohio Schools Director on the AIA Ohio Board of Directors. In November 2022, I was fortunate to be recognized as *Architect of the Year* by AIA Toledo. In August 2023, I was appointed as a Board Member on the AIA Ohio Foundation, and in September 2023, I was appointed Faculty Ambassador to the Paul J. Hooker Center for Entrepreneurial Leadership in the Schmidthorst College of Business at BGSU. Within these and my other leadership capacities, I have meaningfully represented and provided visibility to my unit at the regional, national and international levels.

The structure and core-values of the College clearly highlight the impact and significance of architecture, planning, landscape architecture; construction management, industrial design, and graphic design on the user, the environment, and the broader socio-economic-cultural context. This vision to provide a more holistic and collaborative learning modality, resonates deeply with a *Systems Thinking* approach that has formed the foundation of my own career – one that is deeply rooted in a multi-disciplinary background centered on academic leadership, research scholarship, professional practice and service. Given the alignment of the vision of the College with my background, qualifications, and experience, I welcome the opportunity to serve as the Dean of the College of Architecture, Design and Construction.
