# A motion to amend Article III, Section 3 of the A&P Constitution as follows:

## ARTICLE III, SECTION 3: ELIGIBILITY

An Assembly member must have served <u>as an elected member of the Assembly</u> for one full year-on the Assembly, within the last five years, <u>before becoming eligible prior</u> to <u>taking office on the Executive Committee</u>. An Assembly member who has served less than one full year as an elected <u>member of the Assembly may</u> be nominated for<del>an Executive Committee</del> office. In addition, an assembly the Executive Committee if that Assembly member will have completed one full year by the beginning of the term of the position for which the person is being nominated.

Additionally, an Assembly member must bave have served on the Executive Committee, for one full year, within the last five years, prior to be considered for taking office as chair-elect. An Assembly member who has served less than one full year on the Executive Committee may be nominated for chair-elect if that Assembly member will have completed one full year on the Executive Committee by the beginning of the term of the chair-elect position for which the person is being nominated.

If passed, Article III, Section 3 of the A&P Constitution will read as follows:

## ARTICLE III, SECTION 3: ELIGIBILITY

An Assembly member must have served as an elected member of the Assembly for one full year within the last five years prior to taking office on the Executive Committee. An Assembly member who has served less than one full year as an elected member of the Assembly may be nominated for the Executive Committee if that Assembly member will have completed one full year by the beginning of the term of the position for which the person is being nominated.

Additionally, an Assembly member must have served on the Executive Committee for one full year within the last five years prior to taking office as chair-elect. An Assembly member who has served less than one full year on the Executive Committee may be nominated for chair-elect if that Assembly member will have completed one full year on the Executive Committee by the beginning of the term of the chair-elect position for which the person is being nominated.

# A motion to amend ARTICLE III, SECTION 4. A. and 4. B. as follows:

## A. ELECTION PROCESS

The Nominating Committee shall present two names for each of the offices of chair-elect and secretary and a minimum of three names from the Assembly for the remaining <u>at-large</u> positions. Assembly members shall be notified in writing of the nominees no later than March 15.

If the minimum number of names is not met, the Nominating Committee shall solicit additional names of eligible members and may extend the nomination process by seven (7) calendar days. If the minimum number of names is still not met after the extension, the Executive Committee may waive the requirement by a majority vote and allow the Nominating Committee to present fewer than the required number of names for the office/position.

If the nominee consents, nominations may be made from the floor at the election meeting to be held the first week of April. Election shall be by secret ballot of the Assembly members with a majority of the votes cast required for election. If a majority is not received on the first ballot, a runoff election will be held immediately between the two candidates garnering the largest number of votes. The newly elected officers shall take office July 1 of the year elected.

## **B. ABSENTEE VOTING**

Only Assembly members present at the election meeting will be eligible to vote for Officers in elections of the Executive Committee.

If passed, ARTICLE III, SECTION 4A. and 4.B. will read as follows:

## A. ELECTION PROCESS

The Nominating Committee shall present two names for each of the offices of chair-elect and secretary and a minimum of three names from the Assembly for the remaining at-large positions. Assembly members shall be notified in writing of the nominees no later than March 15.

If the minimum number of names is not met, the Nominating Committee shall solicit additional names of eligible members and may extend the nomination process by seven (7) calendar days. If the minimum number of names is still not met after the extension, the Executive Committee may waive the requirement by a majority vote and allow the Nominating Committee to present fewer than the required number of names for the office/position.

If the nominee consents, nominations may be made from the floor at the election meeting to be held the first week of April. Election shall be by secret ballot of the Assembly members with a majority of the votes cast required for election. If a majority is not received on the first ballot, a runoff election will be held immediately between the two candidates garnering the largest number of votes. The newly elected officers shall take office July 1 of the year elected.

#### B. ABSENTEE VOTING

Only Assembly members present at the election meeting will be eligible to vote in elections of the Executive Committee.

# A motion to amend ARTICLE II, SECTION 2: DEFINITION as follows:

All employees of Auburn University classified as Administrative and Professional are considered members in the Administrative and Professional employee grouping. The Administrative and Professional Assembly is the body elected to represent the Administrative and Professional employee grouping. "Assembly" and "Assembly members" refers to this group of representatives and officers.

Administrative and Professional employees who have been employed by Auburn University for one year or longer at the time of nomination are eligible for nomination and election to the Assembly as a Place Representative. A&P employees who have served as an elected member of the Assembly for one term or longer are eligible for nomination and election to the Assembly as an Executive Committee Officer. Administrative and Professional employees are eligible for nomination and election to the Assembly if they have been employed by Auburn University for one year or longer prior to the beginning of the term of the position for which the person is being nominated.

If passed, ARTICLE II, SECTION 2: DEFINITION will read as follows:

All employees of Auburn University classified as Administrative and Professional are considered members in the Administrative and Professional employee grouping. The Administrative and Professional Assembly is the body elected to represent the Administrative and Professional employee grouping. "Assembly" and "Assembly members" refers to this elected body of representatives and officers.

Administrative and Professional employees are eligible for nomination and election to the Assembly if they have been employed by Auburn University for one year or longer prior to the beginning of the term of the position for which the person is being nominated.

# A motion to amend ARTICLE II, SECTION 3.A, 3.B, and 3.D as follows:

## **SECTION 3: REPRESENTATION**

## A. NUMBER OF MEMBERS

The Assembly shall be composed of no more than twenty-five elected members. The Executive Committee will be included in this number.

The chair and the chair-elect will not be included in the proportional distribution of the Assembly. The chair-elect shall be elected from the elected Assembly membership, and the vacated position will be available to be filled from the appropriate university vice-presidential and presidential categories during the Assembly elections in the spring.

## B. PROPORTIONAL REPRESENTATION

Representation on the Assembly shall be proportional and distributed among the colleges and schools, in addition to the vice-presidential and presidential categories as determined by the Executive Committee prior to the annual elections.

The chair and the chair-elect will not be included in the proportional distribution of the Assembly. The chair-elect shall be elected from the pool of Assembly members who have served on the Executive Committee at least one full year within the five years prior to taking office on the Executive Committee. If the election of the chair-elect causes a vacancy, the vacated position will be available to be filled from the appropriate university vice-presidential and presidential categories during the Assembly elections in the spring.

#### D. ELECTIONS

Each category shall hold its own election to elect its representative(s) in accordance with general guidelines set by the nominating committee. Election of the Assembly representatives members will be held the first week of each May, and election of the Executive Committee will be held the first week of April. The newly elected officers, the Executive Committee, and the Assembly representatives will take office July 1 of the year elected.

If passed, ARTICLE II, SECTION 3.A, 3.B, and 3.D will read as follows:

## **SECTION 3: REPRESENTATION**

## A. NUMBER OF MEMBERS

The Assembly shall be composed of no more than twenty-five elected members. The Executive Committee will be included in this number.

## B. PROPORTIONAL REPRESENTATION

Representation on the Assembly shall be proportional and distributed among the colleges and schools, in addition to the vice-presidential and presidential categories as determined by the Executive Committee prior to the annual elections.

The chair and the chair-elect will not be included in the proportional distribution of the Assembly. The chair-elect shall be elected from the pool of Assembly members who have served on the Executive Committee at least one full year within the five years prior to taking office on the Executive Committee. If the election of the chair-elect causes a vacancy, the vacated position will be available to be filled from the appropriate university vice-presidential and presidential categories during the Assembly elections in the spring.

## D. ELECTIONS

Each category shall hold its own election to elect its representative(s) in accordance with general guidelines set by the nominating committee. Election of the Assembly representatives-will be held the first week of each May, and election of the Executive Committee will be held the first week of April. The newly elected officers, the Executive Committee, and the representatives will take office July 1 of the year elected.
