GETF Charge

A. Review the University's current general education requirements.

AU Core Curriculum 41 hours

- · English Composition (6 sem hrs)
- World Literature (6 sem hrs in sequence)
- Philosophy (3 sem hrs)
- · Fine Arts (3 sem hrs)
- Mathematics (3 sem hrs)
- Science (8 sem hrs in sequence or 4 hrs combo with Concepts of Science)
- World History (6 sem hrs in sequence)
- Social Science (6 sem hrs: 3 hrs each from two groups)

Recommendation One:

Use the flexibility available in the current Alabama Articulation and General Studies Committee (AGSC) agreement to provide a more inclusive approach to Auburn University's general education requirements.

Steps can be taken within our current Core:

1. Eliminate course requirements that are not part of the AGSC agreement:

Within Current Core:

- Reduce the two required sequences (one in Area II, one in Area IV) to one required sequence.
- b. Make philosophy an option in the arts and humanities area.
- Bring the science requirement in line with AGSC.

Another Step

2. Offer a longer menu of courses:

Sources of Potential Courses

- a. Auburn University courses not currently part of the Core Curriculum.
- b. New Auburn University courses similar to
 - AGSC-approved courses offered at other state institutions.
 - 2) Courses from peer institutions outside the state.

Other Course Considerations:

- Departments/programs should not restrict course selection by students unless there is a compelling reason.
- Exempt students from selected Core courses if students have high scores on appropriate tests.

Recommendation Two:

Clarify the relationship between the current Core Curriculum and Auburn University's general education outcomes.

To Clarify Relationship

- 1. Review the current Core as it relates to general education outcomes.
- 2. Verify that Core courses address the major competencies of the general education goals with which they are identified.

Recommendation Three:

Expand the role of the Core Curriculum Oversight Committee to cover general education outcomes.

Recommendation Four:

Action on Recommendations One, Two, and Three begin by the end of 2009.
