#### d. Curriculum Development

Families in Business (OSU CSCFFS 3270). Spring 2020. Major Revision.

I completely restructured the curriculum for CSCFFS 3270 in Spring 2020, a junior level course in the Consumer and Family Financial Services program that frequently draws upwards of 50 students. The course discusses small to medium business management issues. I implemented the course in Spring 2020 in a flipped classroom model by using UCAT experiences and real company case discussions. To transform the course into online version, I used virtual meeting software to held virtual classes in-class discussions, and office hours.

Family Tax Planning (OSU CSCFFS 4260). Spring 2018 -- Spring 2020. Revision.

I completely overhauled the curriculum for CSCFFS 4260, a senior level course in the Consumer and Family Financial Services program that frequently draws upwards of 50 students. The course introduces U.S. income tax system and is a part of the required coursework for Certified Financial Planner® (CFP) exam. My revision included: a newly developed syllabus with real life cases and quizzes for every week; new reading assignments and explanations of newly reformed individual tax system. In Spring 2020, I transformed the course into online version, including using voice-over lectures, virtual classes, in-class cases, and office hours, and online final exam. I maintained an effective virtual communication system with students to implement teaching best practices to increase engagement across all sessions of the course.
