

IMPORTANT PROGRAM DATES FOR THE SPRING 2018 SESSION

Monday, August 21, 2017	Earliest start of online Preparation Class (HUSC 3383). <i>Students will be notified by email of the actual start date which will be during the Fall 2017 semester. Most coursework will be completed two weeks prior to departure with a final assignment due upon arrival in Italy. Grades will be received during the semester in Italy.</i>
Monday, January 29, 2018	Depart U.S. for Italy with arrival on the following day, Tuesday, January 30, 2018. <i>Students are free to choose any flight(s) and itinerary that will put them in Rome on this day. Upon arrival at Fiumicino airport (FCO) in Rome, students are met by JSB staff or private drivers. Transportation from FCO to Ariccia is arranged and provided by the program.</i> <i>Itineraries that arrive in Rome before or around noon are not mandatory, but do have the advantage of allowing students to unpack, settle in, and participate in the afternoon group activities. These activities begin at 4:00 pm but attendance is not mandatory.</i> <i>Students arriving before Tuesday, January 30 are responsible to arrange and cover the expenses of transportation from the airport to their lodging and from their lodging to the campus on Tuesday.</i>
Friday, March 9, 2018 – Sunday, March 18, 2018	Midterm Break
Saturday, April 21, 2018	Return to U.S. <i>Departure from the program prior to this day for any reason will be considered an unexcused absence and will significantly impact a student's final grades.</i>

VISA INFORMATION

Students participating in Joseph S. Bruno Auburn Abroad in Italy are traveling as a tourist which allows them to be in certain European countries (including Italy) for a maximum of 90 days without a visa. The JSB program uses 83 of the 90 days allowed for this type of travel. A visa is not required.

IMPORTANT BILLING DATES FOR THE SPRING 2018 SESSION

Wednesday, July 3, 2017	SESSION COMMITMENT DAY <i>Last day students can transfer their enrollment to another semester without losing their deposit. Transferring to another semester beyond this day will require payment of a new \$1,500 deposit.</i>
Monday, September 4, 2017	Payment of 50% of the Program Fee is due (less the deposit amount).
Monday, September 4, 2017	21 weeks until departure <i>On this date through October 8, 2017, students are responsible for payment of 25% of the Program Fee upon withdrawal from the Program or transfer to another semester. Any payments that have been made above this amount will be refunded.</i>
Monday, October 9, 2017	Payment of remaining 50% of the Program Fee is due.
Monday, October 9, 2017	16 weeks until departure <i>On this date through November 5, 2017, students are responsible for payment of 50% of the Program Fee upon withdrawal from the Program or transfer to another semester. Any payments that have been made above this amount will be refunded.</i>
Monday, November 6, 2017	12 weeks until departure <i>On this date through December 3, 2017, students are responsible for payment of 75% of the Program Fee upon withdrawal from the Program or transfer to another semester. Any payments that have been made above this amount will be refunded.</i>
Monday, December 4, 2017	8 weeks until departure <i>Students are responsible for payment of 100% of the Program Fee upon withdrawal from the Program on and after this date. No refunds will be given.</i>
