

## IMPORTANT PROGRAM DATES FOR THE SUMMER 2017 SESSION

January 11, 2017	Earliest start of online Preparation Class (HUSC 3383). <i>Students will be notified by email of actual start date which will be during the Spring 2017 semester. Most coursework will be due two weeks prior to departure with a final assignment due upon arrival in Italy. Grades will be received during the semester in Italy.</i>
Monday, May 8, 2017	Depart U.S. for Italy with arrival on the following day, Tuesday, May 9, 2016. <i>Students are free to choose any flights that arrive in Rome on this day. Transportation from the Fiumicino airport in Rome to Ariccia is arranged and provided by the program. Optional group activities are scheduled to begin at 4:00pm. Flights that arrive in Rome before or around noon are not mandatory, but do have the advantage of allowing students to unpack, settle in, and participate in the afternoon group activities. Students arriving before Tuesday, May 9 are responsible to arrange and cover the expenses of transportation from the airport, off-campus lodging, and transportation to the campus on Tuesday.</i>
Friday, June 16, 2017 – Sunday, June 25, 2017	Midterm Break
Saturday, July 29, 2017	Return to U.S. <i>Departures from the program prior to this day for any reason will be considered unexcused absences and will significantly impact a student's final grades.</i>

## IMPORTANT BILLING DATES FOR THE SUMMER 2017 SESSION

Monday, November 1, 2016	SESSION COMMITMENT DAY <i>Last day students can transfer their enrollment to another semester without losing their deposit. Transferring to another semester beyond this day will require payment of a new \$1,500 deposit.</i>
Friday, November 11, 2016	Payment of 50% of the Program Fee is due (less the deposit amount).
Monday, December 12, 2016	21 weeks until departure <i>Students are responsible for payment of 25% of the Program Fee upon withdrawal from the Program on this date through January 15, 2017. Any payments that have been made above this amount will be refunded.</i>
Friday, January 6, 2017	Payment of remaining 50% of the Program Fee is due.
Monday, January 16, 2017	16 weeks until departure <i>Students are responsible for payment of 50% of the Program Fee upon withdrawal from the Program on this date through February 12, 2017. Any payments that have been made above this amount will be refunded.</i>
Monday, February 13, 2017	12 weeks until departure <i>Students are responsible for payment of 75% of the Program Fee upon withdrawal from the Program on this date through March 12, 2017. Any payments that have been made above this amount will be refunded.</i>
Monday, March 13, 2017	8 weeks until departure <i>Students are responsible for payment of 100% of the Program Fee upon withdrawal from the Program on and after this date. No refunds will be given.</i>
