

IMPORTANT PROGRAM DATES FOR THE SUMMER 2018 SESSION

Wednesday, January 10, 2018	Earliest start of online Preparation Class (HUSC 3383). <i>Students will be notified by email of the actual start date which will be during the Spring 2018 semester. Most coursework will be completed two weeks prior to departure with a final assignment due upon arrival in Italy. Grades for this class will be received during the semester in Italy.</i>
Monday, May 7, 2018	Depart U.S. for Italy with arrival on the following day, Tuesday, May 8, 2018. <i>Students are free to choose any flight(s) and itinerary that will put them in Rome on this day. Upon arrival at Fiumicino airport (FCO) in Rome, students are met by JSB staff or private drivers. Transportation from the airport to Ariccia is arranged and provided by the program.</i> <i>Flights that arrive in Rome before or around noon are not required but are recommended as they have the advantage of allowing students to unpack, settle in, and participate in the optional afternoon group activities that begin around 3:00pm.</i> <i>Students arriving in Italy before Tuesday, May 8 are responsible for arranging and covering the expenses of transportation from the airport to their lodging and from their lodging to the campus on Tuesday.</i>
Friday, June 15, 2018 – Sunday, June 24, 2018	Midterm Break
Saturday, July 28, 2018	Return to U.S. <i>Departure from the program prior to this day for any reason will be considered an unexcused absence and will significantly impact a student's final grades.</i>

VISA INFORMATION

Students participating in Joseph S. Bruno Auburn Abroad in Italy are traveling as a tourist which allows them to be in certain European countries (including Italy) for a maximum of 90 days without a visa. The JSB program uses 83 of the 90 days allowed for this type of travel. A visa is not required.

IMPORTANT BILLING DATES FOR THE SUMMER 2018 SESSION

Wednesday, November 1, 2017	SESSION COMMITMENT DAY <i>Last day students can transfer their enrollment to another semester without losing their deposit. Transferring to another semester beyond this day will require payment of a new \$1,500 deposit.</i>
Friday, November 10, 2017	Payment of 50% of the Program Fee is due (less the deposit amount).
Monday, December 11, 2017	21 weeks until departure <i>On this date through January 14, 2018, students are responsible for payment of 25% of the Program Fee upon withdrawal from the Program or transfer to another semester. Any payments that have been made above this amount will be refunded.</i>
Friday, January 5, 2018	Payment of remaining 50% of the Program Fee is due.
Monday, January 15, 2018	16 weeks until departure <i>On this date through February 11, 2018, students are responsible for payment of 50% of the Program Fee upon withdrawal from the Program or transfer to another semester. Any payments that have been made above this amount will be refunded.</i>
Monday, February 12, 2018	12 weeks until departure <i>On this date through March 11, 2018, students are responsible for payment of 75% of the Program Fee upon withdrawal from the Program or transfer to another semester. Any payments that have been made above this amount will be refunded.</i>
Monday, March 12, 2018	8 weeks until departure <i>On and after this date, students are responsible for payment of 100% of the Program Fee upon withdrawal from the Program or transfer to another semester. No refunds will be given.</i>
