

Conifer Nurseries	Regeneration Weevils	2 quarts per 100,000 trees (approximately 1 1/4 acres)

DIRECTIONS FOR USE:

Nursery Spray

Apply Pounce 3.2 EC at the rate of 2 quarts (1.6 pounds of active ingredient) per 100,000 trees in enough water to achieve thorough coverage.

Apply Pounce 3.2 EC using ground application equipment. Do not apply aerially.

Make no more than one application per acre per season.
