AURA: CONTINUING PROGRESS Don Seay, President (2014-15)

ast year, under the leadership of President Larry Mullins, AURA made

progress in many areas. His article in the Spring 2014 issue of AURA News, "Looking to the Future of AURA", provided details of our progress. As I like to say regarding science and medicine, "We have only scratched the surface in our discoveries of solutions to problems and cures for diseases and other health problems". Likewise, AURA has only scratched the surface in our potential to be of service to all of our members.

As Larry pointed out, your Board of Directors has agreed AURA needs to have both a political and a social focus in order to serve the membership. On the political side, AURA was founded for university retirees to have a voice with the Auburn University and Auburn University Montgomery administrations and the state legislature regarding retiree benefits, specifically cost of living increases (COLAS) and reasonable costs for medical and drug benefits. The social focus has mainly been our spring business and luncheon meeting and our fall "BAR-B-Q" event.

As you are aware, our PEEHIP medical insurance and drug benefits costs this year remain at last year's level. This was no accident.

The Alabama Education Retirees Association (AERA) has a huge number of active members and an executive director, Janice Charlesworth. They organized and lobbied the legislature in Montgomery and were successful in maintaining these benefits. We each have benefited from those efforts. I am aware that in the past, there has been a divide between AERA, the K-12 retiree group, and AURA, the university retiree group. At this point in history, the continuation of this divide is not helpful. Now more than ever in recent history it takes large numbers of voices to be heard and to receive attention. By necessity, AURA must collaborate with AERA and other universities in the state to present a unified educational voice in pursuit of our interests. AERA has now provided a seat on their board of directors for a representative from the university community. We must accept this opportunity to extend our voice. That seat is in the process of being filled by the higher education community. If you are not now a member, I urge you to join AERA as well as maintaining your AURA membership.

Speaking of numbers, AURA has not done well in attracting new retirees. Currently only about 7% of retirees have been joining AURA. Your Board of Directors

is making an effort

to increase this percentage significantly by increasing the benefits of membership. Plans are in process to meet with both President Gogue and Chancellor Veres to discuss how we can obtain better access to persons retiring and how AURA and the universities can better interact to the advantage of both. In order to be effective, we simply must attract more members and increase our voice.

On the social side, we plan to continue our spring business meeting / luncheon and our fall evening event, as well as providing information of other social venues of interest to retirees. Our goal is to disseminate information of interest to Auburn University and Auburn University Montgomery retirees through the newsletter and on the AURA website. Information including proposed Alabama Retirement System related legislation; ongoing developments and news of interest at both institutions; information about organizations within our local communities that support retirees and provide life enriching opportunities; and other useful information in areas of life that affect each of us.

Currently AURA has a Website accessed through the Auburn University Website. One of our primary goals this year is to establish an upgraded AURA Website. It will provide easier access to AURA information. I think this goal is imperative in order to have more timely communication with each of you and with new members. Three newsletters a year are simply not sufficient to keep us up to date. Currently we are restricted on the quantity and subject matter of items that can be placed on the university Website. Additionally, although Larry Mullins and previous editors have done a remarkable job in compiling and publishing each newsletter, it is very expensive to print and mail. Printing costs are approximately \$1200 per issue, plus approximately \$200 for postage. As we increase our membership, that cost will only grow.

Thousands of dollars can be saved and applied to the attainment of our goals

by publishing the newsletter on our website. (Of course, there will have to be accommodation for those without access to the Website.)

At this time your Board of Directors is fully staffed with excellent representatives from our membership. This newsletter contains a list of all board members and their email addresses for your use in making contact with us. PLEASE BE AWARE, THE BOARD ALONE CANNOT ACOMPLISH EVERYTHING THAT MUST BEDONE. CONTACTUS AND VOLUNTEER TO SERVE ON A COMMITTEE OR GROUP THAT IS WORKING TOWARD IMPROVING AURA.

Meanwhile we will use the current university website to keep you informed on progress regarding the new Website and other important information. Find it by going to auburn.edu and then typing "retiree" (no quote marks) into the search box at the top right of the page. •


In 1994, the University decided to change the retirement system by moving Auburn University retirees to the Retirement Systems of Alabama (RSA). In that move, Auburn retirees were going to lose some retirement benefits and options. Dr. Bailey led the effort to address that inequity and the result was the formation of AURA. I have been retired for seventeen years and just a couple of weeks ago I received one of the periodic small checks I get from AU that is a result of that

ests of AURA retirees and all education retirees.

At the last Annual Meeting of AERA, some 700 delegates from across the state, mostly K-12 retirees, adopted a constitutional change that provides for a seat for an elected higher education retiree on the AERA Board of Directors. This was not an easy decision for K-12 retirees to make. But, in the end, the historical tensions that may have existed between higher education and K-12 were set aside in a show of unity with the common goal of supporting and advocating for all education retirees. Thus, the work of AURA continues and is enhanced.

AURA is important. I am pleased and honored to play a role in AURA and to be an advocate for Auburn University retirees and all education retirees. In my current role as Director of the Capital Survey Research Center, one of the things I do is to conduct special and annual surveys of education retirees. You may be interested in some of the findings from the most recent survey.

CONSIDERATIONS OF ACADEMIC STRUCTURE CHANGES AT AUBURN UNIVERSITY AT MONTGOMERY

he Strategic Plan (2013-2018) for Auburn University at Montgomery states that the university will "evaluate and adjust the university academic structure to optimize efficiency." To this end, the Provost appointed a nine member Academic Reorganization Advisory Committee consisting of two faculty representatives from the School of Liberal Arts, two representatives from the School of Sciences, and one representative from the School of Business, School of Education, School of Nursing, the Library and Faculty Senate. The Committee was charged with reviewing the current organization of academic units at AUM and making recommendations for a more effective organization of these units, the elevation of Schools to Colleges, a structure that would promote future growth, a structure that makes sense from an organizational perspective, and a structure that aligns the university with its Strategic Plan.

The Committee set about gathering information from internal and external sources. Internally an email account was established to receive comments and suggestions from faculty. Committee members also met with various faculty, hosted two forums open to all faculty and staff and held meetings with department heads and deans. Data on enrollment and credit-hour production by departments and schools was also collected and analyzed. External information included review of the academic organization at our peer and aspirant universities.

After extensive deliberation, the Committee recommended a reorganization plan to the Provost. The Provost made some modifications to the plan and, to date, has attended faculty meetings in the Schools of Sciences, Liberal Arts and Nursing to receive faculty feedback on this plan. The plan will be discussed at upcoming meetings of the Faculty Senate and Faculty Council. All comments and suggestions will be considered in formulating a final draft of the plan to be submitted for approval to the Auburn University Board of Trustees. The University will begin implementation of the plan in the academic semester following Board approval. This is a work in progress and any in-depth discussion of a particular plan prior to Board approval would be premature.

with the overall job they are doing and believe (92%) they get their money's worth in AEA/AERA membership.

- The attributes and characteristic of retires are changing. In 2005, 54% of education retirees had access to e-mail and the internet. By 2012 that had increased to 69% and continues to climb.
- The three most important things that education retirees believe that AEA and AERA does for them are keeping health care cost low (80%), protecting the retirement program (73%) and advocating for COLAs (51%).
- Retirees (62%) prefer no COLA increase in order to prevent an increase in health care costs. This is precisely where retirees are in the state today. In the just ended session of the Legislature retirees did not get a COLA increase. Rather, the Legislature adopted a budget that included some \$77 million to help PEE-HIP fund a \$220 million deficit. PEEHIP will use reserves to complete the funding for FY 2015. There will be no increase in premiums or out-of-pocket expenses for FY 2015. However, for FY 2016 the projected deficit is \$345 million and for FY 2017 \$417 million. Without additional revenues both premiums and service costs will increase or services will be reduced. AURA's work is not finished.
- When given options to avoid a reduction in health care services, retirees do not have a consensus position. Forty-four percent supports an increase in copays, 37% an increase in deductibles, 35% an increase in premiums and 25% supports a spousal surcharge.
- In the political arena, 36% of education retirees say they vote straight Democratic Party, 11% straight Republican Party and 45% split their vote.
- However, when asked which political party they believe does the best job for education retirees, 61% says the Democratic Party and 17% the Republican Party.
- Seventy-eight percent believes AEA and AERA should be active in the Legislature and helping elect candidates who support public education and public school personnel and retirees. Eighty percent believes public schools and employees and retirees would be worse off if AEA and AERA were not strong voices for public education.
- Education retirees have mixed feelings about the future soundness of both the state's education retirement and health care programs. Forty-sev-

en percent has confidence in the future of the retirement programs while 50% has concerns. Thirty-nine percent is confident of the future of the health care programs while 57% is concerned.

These data provide a testimonial of retiree concerns and priorities and are helpful to AURA, AERA and AEA in telling the story of the interests of education retirees to those who make the policy decisions that impact the welfare of education retirees. AURA is important.
