



The Auburn University Health Care and Education Clinic (AUHEC or "Boykin Clinic") is a collaborative project between AU and the City of Auburn. Located within the Boykin Community Center in Northwest Auburn, the clinic offers health care services for Auburn residents who are uninsured, underinsured or prefer to access health care in Northwest Auburn. The clinic serves as an education and interprofessional training center, offering a site for Auburn University students

from multiple disciplines to engage with each other and learn how to collaboratively care for patients from a variety of backgrounds in a real-life setting. My role is administrator in charge of the clinical and pharmacy services and overall clinical and business operations. Developed business plan for this outreach as care is subsidized for patients who are underinsured and uninsured and meet financial criteria. This is a different business model than the one used in other CHS clinics and pharmacies. In 2019, the AUPCC Population Health Clinic was founded. The first project received for this new service came from Tuscaloosa VA. CAO is collaborating with this VA to utilize quality metrics / dashboards to identify patients in need of attention based on one or more quality indicators. Second year pharmacy students (P2s) work with faculty to review patients charts and provide a holistic review of patient care. Once prepared, P2 students, supervised by faculty and preceptors, utilize telehealth to contact patients when indicated. Faculty have scope of practice so the team can order vaccines, renew medications, and adjust regimens as needed. More complex patients with multiple disease states and polypharmacy are referred to the AUPCC for P4s in the main clinic to focus on the care of these patients. The population health clinic is a wonderful practice setting for the experiential training of students and residents. Several projects have been funded to advance this service (from NACDS).
