## Medical Clearance Policy

When you are ready to return to campus after a medical withdrawal, you must adhere to our medical clearance policy. If your health care provider does not recommend that you are ready to return to an academic environment for future semesters in their initial medical letter to our office, a medical clearance hold will be placed on your account. To resolve this hold, you need to submit medical documentation indicating readiness to return to Auburn. This documentation can be emailed to [medwithdraw@auburn.edu](mailto:medwithdraw@auburn.edu) or mailed/faxed to the address below.

Upon the semester of your return after a medical clearance hold, you are also required to schedule a re-entry meeting with Auburn Cares by emailing [medwithdraw@auburn.edu](mailto:medwithdraw@auburn.edu) or calling 334-844-1305. You must submit your medical documentation and contact Auburn Cares to schedule your re-entry meeting 14 days prior to the first day of classes of the semester that you plan to return. If you have already registered for the following semester, your schedule may be dropped if you do not complete these steps.
